# COASTAL ZONE CONVERSION PERMIT ACT RISK EVALUATION AND FINANCIAL ASSURANCE WORK GROUP MEETING #1 SEPTEMBER 5, 2018 MEETING SUMMARY

APPROVED BY THE RISK EVALUATION AND FINANCIAL ASSURANCE WORK GROUP ON SEPTEMBER 19, 2018

### **MEETING IN BRIEF**

The meeting covered: 1) an introduction to the statute regarding financial assurance and risk evaluation, 2) an overview of financial assurance and common financial assurance instruments and their use in a regulatory context, 3) discussion of the scope of issues to cover, and 4) next steps. ## **SUMMARY OF KEY POINTS**

Work Group members raised a variety of issues for consideration as the process continues:

- While much of the first meeting focused on financial assurance topics, the risk evaluation component of this work group is important and will need to be integrated with the logistics of financial assurance.
- While the CZCPA is not intended to revisit existing decision-making under the CZA and other federal, state, and local laws and regulations, the existing environmental and risk evaluation/financial assurance context of the 14 sites relevant to the CZCPA is important to understand. Additional site-related information should be provided to WG members as background.
- As a general matter, CZCPA financial assurance should be integrated with existing financial assurances applicable to the site, addressing Delaware's financial assurance needs where existing coverage is absent or insufficient in some manner.
- Coastal Zone conversion permit financial assurance should be cognizant of other federal, state, and local statutes and regulations that come into play if particular types of events occur (e.g., Oil Pollution Act of 1990 for oil spills).
- O WG focus should be on ensuring that sufficient funding is available in an appropriate instrument to undertake key actions to protect the environment and human health in the event of nonperformance by the Applicant. The probability of any such events occurring primarily affects the cost of obtaining financial assurance and is not a primary WG focus. Nevertheless, event probabilities may still factor into WG discussion of risk evaluation and financial assurance topics.
- The potential for financial assurance related to: a) CZCPA offsets, b) economic incentives provided to an owner/operator, and 3) third-party liability/claims by private parties were briefly discussed but may be out of scope for the WG further clarification is needed.
- Financial assurance to ensure regulators have access to sufficient funding to address environmental needs in the event of non-performance by a facility owner/operator were deemed important to consider
- o It may be helpful for the WG to identify and briefly review examples of state or federal financial assurance regulations.
- Other topics brought up but placed into a "parking lot" to potentially address later include: 1) ways to integrate risk into conversion permit financial assurance (e.g., basing financial assurance

on "risk buckets" that take into account a variety of variables [e.g., proximity of a site to the shoreline, proactive measures taken by the applicant to reduce risk, risk to neighboring sites/off-site impacts], pooling the 14 sites into an insurance framework); 2) liability if a developer were to dig into an already capped contaminated site; and 3) considering the complexities of financial assurance for a brand new development vs. an expansion of an already-developed site

Next steps include IEC, the technical consultant, bringing forward additional information about existing FA regulations and identifying options under various issues named in the scoping paper distributed the meeting. DNREC will provide additional contextual information about the 14 sites relevant to the CZCPA. The next Offset WG meeting is: Wednesday, September 19, 1:00pm – 4:30pm, Grass Dale Center, 108 N.
