The Department of Natural Resources and Environmental Control (DNREC), Division of Climate, Coastal and Energy will conduct a virtual public hearing on Wednesday, July 28, beginning at 6:00 p.m. to consider comments from the public on the proposed revisions to 7 DE Admin. Code 2103 "Regulations for the Green Energy Program."

The objectives of revising 7 DE Admin. Code 2103 are to update and simplify regulatory language.
