Notice of Public Hearing

The DNRECDCCE will conduct a public hearing on the proposed amendments to Delaware Administrative Code 2101: Regulations for State Energy Conservation Code (Docket #2019-R-CCE-0020). These amendments are being proposed to adopt the 2018 International Energy Conservation Code (2018 IECC) and American Society of Heating, Refrigerating and Air-Conditioning Engineers Standard 90.1-2016 (ASHRAE 2016) in their entirety as the statewide energy conservation code.

The public hearing will be held on **Tuesday, December 3, 2019, beginning at 6:00 PM at DNREC's office located at 89 Kings Highway, Dover, DE.**
