DNREC is Forming a New UST Advisory Committee

DNREC's Tank Management Section (DNREC-TMS) is forming an Underground Storage Tank (UST) Advisory Committee (USTAC) to assist the Department in making changes to the Delaware Regulations Governing Underground Storage Tank Systems and to maintain an open dialogue with the regulated community on matters affecting underground storage tanks. Delaware will be updating the regulations to maintain consistency with the Federal UST Program, which changed its regulations in October 2015. In addition, changes will be made to clarify issues and to encourage the use of new technology and best management practices. The DNREC-TMS will be holding the first USTAC meeting at 10:00 AM on Wednesday October 26th, 2016 at the DNREC Lukens Drive Office located at 391 Lukens Drive New Castle DE 19720.

EPA Publishes a Report on Diesel Tank Corrosion

Corrosion has been commonly reported in USTs storing diesel fuel and gasoline-ethanol blended fuels. The corrosion generally appears in different areas of the UST system for each fuel. When storing diesel fuel, corrosion generally appears on metal components inside USTs. When storing ethanol blended fuels, corrosion generally appears in sumps. UST owners should check for corrosion in their tank systems storing diesel fuel, and if they find corrosion, repair or replace equipment as necessary to ensure proper functionality. EPA has recently studied the problem and published a report which can be found at the following link.

Aging USTs and the impact on private insurance

UST Owners and Operators must maintain financial responsibility for cleanup costs and third party damages as a result of a release from an UST. In Delaware over 80% of the active UST facilities use private insurance to comply with financial responsibility requirements. Tank age is becoming an increasingly important factor utilized by insurance companies to determine the type of insurance coverage offered, retroactive dates, the premium costs for the policy, possible non-renewal of existing policies, and whether a new owner can purchase a policy for an older tank. Owners and Operators may therefore find it increasingly difficult to insure USTs that are over 30 years old. Owners and operators should contact their insurance companies for questions regarding their specific policy and renewal requirements.
