**Subject:** Revised Croda/Request For Public Hearing

This letter/email is revised. The word way is inserted into the first paragraph after the reasons so that the sentence reads “ the only way that they can be a good community partner is to cease operations“.

Dear Secretary Garvin

I am requesting that a public hearing be held regarding the application from Croda to build a storage tank on Cherry Lane within my Council district in New Castle Delaware.

My reasons for this request include but are not limited too;

1.I can't believe that Croda has the unmitigated gull to make this request knowing full well that they caused havoc with a leak in November 2018 and were required to cease operations for an extended period of time.

2. Many community residents were not in agreement with DNREC's decision to allow Croda to begin operations again and not comfortable with the current situation. Therefore, the addition of a storage tank will only cause additional anger and anxiety.

3. The community is concerned that current emergency notifications and directions are woefully insufficient.

4.Croda's operation poses a imminent danger to local residents and all people that use the Delaware Memorial Bridge. The addition of a storage tank is an undue and unfair burden that is simply not acceptable.

5. The current application is yet another example of environmental injustice that will continue to be opposed by every legal means necessary.

Most recently, Croda provided toilet paper and hand sanitizer at the food distribution site currently operating at the Route 9 library. I was concerned at the time that it was dastardly mischief bought forward for an alternative reason. Regrettably, the current application makes it clear that my view was correct. Croda should realize that the only way they can be a good community partner is to cease operations.

I believe that is important that this request for a public hearing for this permit application be held and that the public have an opportunity to be fully heard. Therefore, I am requesting that the public hearing not be held until such time as the meeting can be held in person in a public place.

Finally, I remind you that the Croda's existence and its inherent danger to the community and everybody who utilizes the Delaware memorial bridge is solely DNREC's fault and responsibility.

I thank you for your prompt attention and consideration.
