Dear Mr Kooker:

We are contacting you on behalf of our 150-home Property Owners Association to request that the DNREC Secretary please order a public hearing to be held concerning Artesian Water Company's application to construct/install several thousand feet of pipeline near the Lewes-Georgetown Highway (Rt. 9). Per the DNREC announcement of the application the purpose of this construction is to allow "a future twelve (12) inch diameter Sussex County force to interconnect with the proposed Artesian piping on Park Avenue. This interconnection will allow Sussex County to utilize the *Artesian Beaver Creek wastewater treatment facility for some of their customers in this area.*" The concern of the homeowners in our community is that Sussex County, a public entity, will be using the treatment facility located immediately adjacent to the Meadows of Beaver Creek. We believe the residents of the Meadows of Beaver Creek are entitled to have answers on questions pertaining to the matter, such as: Why is county wastewater going to be transferred (pumped) to a private facility for processing? How much will the volume of waste treated at this facility increase? What will this mean, in practical terms, to residents of the Meadows of Beaver Creek, in regard to day-to-day activity at the facility? Has consideration been given to property values in the development as a result of taking in public sewage to a private facility in immediate proximity to our development?

We further believe that homeowners in the development are entitled to know the specifics of what is planned by the County, Artesian and DNREC. For this to be done without a hearing seems improper, given that this activity will have a direct impact on the property owners of this community.

Good Afternoon,

We are residents of the Meadows of Beaver Creek development in Milton Delaware. It has recently come to our attention that Artesian has applied to construct several thousand feet of pipe near the Lewes Georgetown Highway in Sussex County. The purpose of this is to allow a future 12 inch diameter Sussex County force to interconnect with the proposed Artesian piping on Park Avenue. This interconnection will allow Sussex County to utilize the Artesian Beaver Creek wastewater treatment facility for some of their customers in this area. I take this to mean that the county will be using the treatment plant immediately adjacent to our development, Meadows of Beaver Creek (MOBC).

As home owners who recently purchased a new home in this development (July 2019), we have concerns regarding this project. First, we had no idea that this was being considered when we made the decision to move here to this development. Secondly, this is actually in MOBC's back yard. We would like to know why county sewage is being pumped to a private facility. Additionally, how will this increase the volume of waste being treated at this facility? How will this impact the quality of life for MOBC residents in terms of increased traffic at the facility, potential sewage leaks at the facility or in the pipeline, and in future property values of this community? Why is this location being selected? Why was this not shared with us when we made the decision to sign a contract to purchase here in December of 2018? I find it hard to believe that this is a recent discussion. We should have been made aware of this before now.

Because of these concerns, we are requesting that a public hearing be held regarding this issue. We will await your reply.

Artesian Water Company proposes to construct approximately eleven thousand seven hundred and thirty-five linear feet (11,735 LF) of twelve (12) inch diameter force main from their existing twelve (12) inch diameter force main at the intersection of the Lewes-Georgetown Highway (Rt. 9) and Gravel Hill Road (Rt. 30), continuing west on Rt. 9 to the Steiner Road intersection, continuing south on Steiner Road approximately one thousand five hundred (1,500) feet to the railroad tracks, and then continuing approximately three thousand five hundred (3,500) feet along the railroad tracks to the Park Avenue intersection in Sussex County. The purpose of this force main extension is to allow a future twelve (12) inch diameter Sussex County force to interconnect with the proposed Artesian force main on Park Avenue. This interconnection will allow Sussex County to utilize the Artesian Beaver Creek wastewater treatment facility for some of their customers in this area.
