The Department of Natural Resources and Environmental Control (DN-REC), Division of Water will conduct a virtual public hearing (Docket #2020-P-W-0029) regarding a Water Allocation permit renewal application submitted by Allen Harim Foods LLC, for its Harbeson Plant. The site is located South of Harbeson in Sussex County, near the intersection of Harbeson Road and Lewes Georgetown Highway.

Allen Harim Foods, LLC (Harbeson) has requested a renewal of its industrial water allocation for four existing industrial wells and one existing public well. The maximum daily withdrawal is 2,300,000 gallons per day. The wells are located south of Harbeson in Sussex County, near the intersection of Harbeson Road and Lewes Georgetown Highway.
