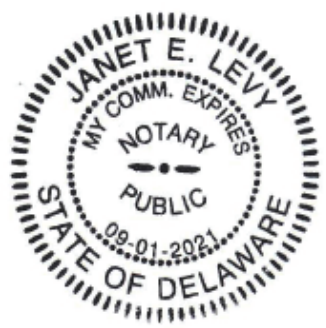

The Department of Natural Resources and Environmental Control, Division of Air Quality, will conduct a virtual public hearing (Docket# 2021-P-A-0005) on the natural minor construction permit application for Atlantic Concrete Company, Inc.
