- Existing 150 tons per hour and 200 tons per hour Concrete Plants
- Construct new 350 tons per hour Concrete Plant
- Decommission old Concrete Plants
- Secretary's Coastal Zone Status Decision limits facility to 200,000 cubic yards of concrete per twelve month rolling period

DAQ Permitting Process

- Review application for administrative and technical completeness
- Determine if the source is in the Coastal Zone and if a Coastal Zone permit is required
- Verify proof of local zoning approval



DAQ Permitting Process-2

- Review technical information and confirm emissions calculations
- Run Air Dispersion modeling to estimate concentration of air pollutants at plant's property line to ensure public health, welfare, and safety will not be adversely affected
- Draft technical memorandum



DAQ Permitting Process-3

- Determine applicable Federal (EPA) and State requirements
- Technical memorandum is the basis for the emission limits, operating limits, monitoring, testing, recordkeeping and reporting requirements in the permit



After Public Hearing

- If Secretary approves the permit, then DAQ will issue a construction permit
- Normal permit conditions include:
 - Recordkeeping and record retention for a minimum of 5 years
 - Reporting of excess emissions or emissions which create a condition of air pollution to the 800 Number
 - Submission of written excess emissions report
 - Conditions that may address concerns raised during the public hearing



DAQ Permitting

- If the construction permit is issued, DAQ will conduct a Constructionto-Operation inspection following the completion of construction
- Following a successful C to O inspection, the company will be issued an operating permit
