Subject: Notification of Draft/Proposed Construction Permit - Croda - 05-28-21

Dear Ms. Opila:

As specified in the Memorandum of Understanding between EPA, Region III and DNREC, State of Delaware, attached is a "draft/proposed" 7 DE Admin. Code 1102 Construction Permit (Pre-Construction Review) for Croda Inc. having a facility at 315 Cherry Lane in New Castle, Delaware, together with DNREC's Technical Memorandum, and a copy of the required public notice. Please note the public comment period ends June 28, 2021. DNREC requests concurrent review of Croda Inc.'s "draft/proposed" Construction Permit. Comments may be submitted for the "draft/proposed" Construction Permit on or before July 13, 2021.





Croda Inc. intends to remove the hotwell as an emission point, further define the operation of the vent scrubber, and correct an error in the emission limits for the ethanol dehydration furnace. The Department will administratively amend Croda Inc.'s Title V permit [**Permit: AQM-003/00058 (Renewal 3) (Revision 5)**] to include all applicable requirements following issuance of the federally enforceable 7 DE Admin. Code 1102 Construction Permit.
