Proposed Amendments to 7 DE Admin. Code 1102 "Permits" (Docket #2021-R-A-0010)

The objective of the amendments to 7 DE Admin Code 1102 "Permits":

To update the public notice publication requirements for general permits, to maintain consistency with the wording of the Environmental Protection Agency's (EPA) current federal regulations

- 40 CFR 70.7(h)(2)
- EPA final rule 81 FR 71613

Proposed Amendments to 7 DE Admin. Code 1102 "Permits" (Docket #2021-R-A-0010)

Proposed language - Sections 12.3.2 & 12.4.2:

Advertising in a newspaper of general circulation in the county in which the activity is proposed and in a daily newspaper of general circulation throughout the State: 1) the fact that the application has been received, the identity of the affected facility, and the city or town in which the facility is located, 2) a brief description of the nature of the application, to include the activity or activities involved in the permit action and the emissions or the change in emission involved, and 3) the name, address and telephone number of a Department representative with responsibility for the permitting action, the place at which a copy of the public file may be inspected, and the name, address, and telephone number of a person (or an email or Web site address) from whom interested persons may obtain additional information, and (4) the time and place of any hearing that may be held, including a statement of procedures to request a hearing (unless a hearing has already been scheduled).
