Notice of Public Hearing**

The Department of Natural Resources and Environmental Control (DNREC), Division of Fish & Wildlife will conduct a virtual public hearing on Thursday, July 22, 2021 beginning at 6:00 p.m. to consider comments from the public on the proposed revisions to 7 DE Admin. Code 3542 "Tilefish".

The objectives of revising 7 DE Admin. Code 3542 are to implement changes to the recreational and commercial daily possession limits and establish a closed recreational season for Blueline Tilefish. These changes will make the Tilefish regulation in Delaware state waters identical to the federal waters regulation.
