1 MS. VEST: The time is now 6:10 p.m. on Thursday, February 21, 2019. 2 And after a 3 ten-minute delay, we are going to go ahead and begin 4 these proceedings. The record should reflect that we did 5 wait an additional ten minutes because there was б 7 some expectation that others might be coming. But at this point we are just going to proceed with the 8 9 people that are here at this point. 10 We are here tonight to provide a 11 platform for the public to come and offer comment, 12 if they wish to do so, regarding the Department's Proposed Revisions to 7 Delaware Admin Code 1140, 13 14 which is to adopt by reference the California 15 Low-Emission Vehicle, or LEV III, and Greenhouse Gas Standards. 16 17 For those of you that do not know me, 18 my name is Lisa Vest. And Secretary Garvin has appointed me to serve as hearing officer for these 19 20 proceedings. 21 A little protocol for tonight, and then we will just go ahead and get to it. 22 23 After these opening remarks, I will 24 turn it over to Department staff. They have a brief



1 statement for the record and, I believe, some 2 exhibits to get entered in. At that point we will open the floor 3 4 up to anyone present that wishes to offer comment for the record. 5 It should be noted that all comment, 6 7 whether received verbally tonight at the hearing or via e-mail or handwritten, received in the mail, all 8 9 bears the same weight. And as long as it all comes 10 in during the period that the comment period is open 11 for, it will all be incorporated into the hearing 12 record and considered by the Secretary prior to his making a decision in this matter. 13 14 To that end, it should also be noted 15 that the record for comment will not close tonight. 16 Pursuant to Delaware law, it will remain open for a 17 full 15 days following tonight's hearing. So, as 18 long as comment is received on or before close of business on Friday, March 8th, it will all bear the 19 same weight, and it will all be taken into 20 21 consideration. That being said, I will turn the 22 23 floor over to Department staff for their brief 24 statement.



1 MS. RABEMIARISOA: All right. So 2 good evening, everyone. Can you hear me fine? 3 So my name is Ajo Rabemiarisoa. I'm 4 an environmental engineer working for the Planning Section of the Division of Air Quality at DNREC. 5 And I'm the leading staff for today's proposed 6 7 regulations, amendments. 8 And here is the Department's 9 statement: 10 On August 24, 2018, the Environmental 11 Protection Agency and the National Highway Traffic 12 Safety Administration have proposed to roll back the Greenhouse Gas Emissions Standards and freeze the 13 14 fuel economy standards for light-duty vehicles to 15 the currently adopted 2020 standards for model years 2021 to 2026, through their Safer Affordable Fuel 16 Efficient (or SAFE) vehicles rule. 17 18 If adopted, the SAFE rule would result in an estimated increase of 1,432 million 19 metric tons of greenhouse gases emissions in the 20 21 atmosphere by 2035. In the light of this proposed rule, 22 23 the California Air Resources Board amended their California Code of Regulations, Sections 1961.2 and 24



1 1961.3, to clarify that the "deemed to comply" provision embedded in California's Advance Clean Car 2 3 program is only applicable with the currently 4 adopted Federal Standards, as last amended on October 25, 2016. The California amendments are 5 effective as of December 12, 2018. б 7 The "deemed to comply" provision was first adopted by California predicating that the 8 U.S. EPA standards are providing greenhouse gas 9 10 emissions reduction equivalent to the California 11 standards. 12 Now, in order to maintain the emissions stringency of the currently adopted 13 14 standards, Delaware needs to clarify that the 15 "deemed to comply" provision only holds true with the Federal Standards, as they exist as of 16 October 25, 2016. 17 18 The Department believes that the currently adopted emissions standards will offer 19 Delawareans an increased quality of life through 20 21 increased economic opportunities, reduced local air pollution, and an opportunity to mitigate the 22 23 effects of climate change on our coastal state. As demonstrated in California's final 24



1 statement of reasons for their respective 2 rulemaking, the currently adopted greenhouse gas 3 emissions standards remain appropriate, 4 cost-effective, and technologically feasible for model years 2021 through 2025. 5 In order to maintain emissions 6 7 standards identical to California's standards, as required by Section 177 of the Clean Air Act, the 8 Department needs to adopt California's latest 9 10 amendments into its Low Emission Vehicle program. 11 On December 27, 2018, Secretary 12 Garvin signed an emergency order to maintain the emissions stringency of the currently adopted 13 14 standards, beginning with model year 2021. 15 Today, we are proposing to preserve 16 the emissions stringency for the 2021 through 2025 17 model year standards. To do so, the Department is 18 proposing to amend 7 Delaware Admin Code 1140, Delaware Low Emission Vehicle program, by 19 incorporating by reference the effective date of 20 21 California's amendments to 13CCR 1961.2 and 1961.3, thus clarifying the Deemed to Comply provision. 22 23 The Department is presenting 11 24 exhibits, as provided herein the exhibits listing,



1 which is also available to you on the table in the 2 back of the room. 3 MS. VEST: Thank you. Let the record 4 reflect that the 11 exhibits provided to me by the Department staff now are hereby entered into the 5 б formal hearing record being generated in this 7 matter. 8 Does the Department have anything additional that they wish to add for the record at 9 10 this time? 11 MS. RABEMIARISOA: Nothing. Thank 12 you. 13 MS. VEST: Okay. Thank you. 14 At this point I will open the floor 15 up to anyone wishing to offer comment. I'm just 16 going on the sign-up sheet that was in back of the 17 room. 18 And, accordingly, Mr. Don Brill, you And if you have any statement -- if you 19 are up. have anything written that you would like to be 20 21 formally entered into the record, I can take that, 22 as well. 23 MR. BRILL: I don't think I do. 24 MS. VEST: Okay.

1 MR. BRILL: Maybe could I make some 2 hand changes? 3 MS. VEST: Or you could e-mail it to 4 me later. Yeah, I will e-mail it. 5 MR. BRILL: MS. VEST: 6 That's fine. 7 MR. BRILL: Do you need name and address? 8 9 MS. VEST: I just need you to spell 10 your full name for the court reporter. 11 MR. BRILL: Don Brill, B-R-I-L-L. 12 So I am here on behalf of Delaware 13 Chapter of the Sierra Club. And I can see we have a 14 large audience. (Laughter) 15 But I first want to just say that we 16 thank the Governor, his administration, for doing 17 that emergency act to make sure that we stayed with California. 18 19 So now we need that amendment now added to the regulations. 20 21 So our director of the Delaware Sierra Club, Sherri Evans-Stanton, prepared a short 22 23 notice for me to read to the group. MS. VEST: 24 Proceed.

1 MR. BRILL: Delaware is uniquely situated because of its low elevation, and it will 2 3 be significantly impacted by sea level rise and 4 climate change. 5 The transportation sector is a major б source of air pollution and greenhouse gases. 7 Children and adults with asthma and other chronic health conditions like heart disease 8 9 and lung disease are particularly sensitive to ozone 10 pollution. 11 Aggressive policy initiatives must be 12 put in place. As a partner in the U.S. Climate 13 Alliance, Delaware needs to incorporate policy 14 initiatives such as promoting the electrification of 15 vehicles, including buses, continuing state rebates 16 for the purchase of EVs -- these are electric 17 vehicles -- increasing EV charging stations, 18 defending clean car standards, and working on local 19 clean transportation solutions. With the current rollback of many 20 21 federal policies designed to protect our air and water quality, it is more urgent than ever that the 22 23 states take an aggressive position of protecting air 24 quality.



1 While our ultimate goal is for 2 Delaware to move towards the zero emission mandate, 3 we commend DNREC for the proposed amendments to meet 4 a higher standard in Delaware's air regulations. The adoption by reference of 5 California's Low Emission Vehicle 3 and the б 7 Greenhouse Gas Standards are a critical step in 8 reducing greenhouse gases. These amendments include more 9 10 stringent emission standards for both criteria 11 pollutants and greenhouse gases for new passenger 12 vehicles. 13 We urge you to adopt these proposed 14 amendments. 15 And that was from Sherri 16 Evans-Stanton, the Director of Delaware Sierra Club. 17 (Applause) Thank you. 18 MS. VEST: Thank you, Mr. Brill. Is 19 there anyone else here present this evening that wishes to offer comment. 20 Yes, ma'am? Could you 21 And it's a small group, so you don't have to stand? come forward. 22 23 MS. MARSICO: Thank you. 24 MS. VEST: But if you could say your

1 full name and spell your last name for the court 2 reporter. 3 MS. MARSICO: Sherry Marsico, M-A-R-S-I-C-O. 4 I also want to commend Delaware in joining with California in their climate alliance. 5 I think it is very important to start 6 7 taking action. And I believe that the proof that we can all see: After a snowfall, you go outside. 8 The first day, the snow is all nice and white. 9 The 10 second, third day, the snow is gray. Four days, 11 it's black. We breathe that in. We can't see it 12 without snow, but it's there. So let's do something 13 about it. Go Delaware. Thank you. 14 MS. VEST: Thank you, ma'am. Anyone 15 else that wishes to offer comment? 16 I want to thank everybody for taking 17 time out of their busy schedules to come tonight. 18 As I said at the beginning of these proceedings, the record does not close with respect to comment at the 19 conclusion of these proceedings. 20 21 Pursuant to Delaware law, the record will remain open for another 15 days. 22 And all 23 comment bears the same weight, whether it comes in 24 tonight verbally at the hearing, or whether I
