Highline Warren LLC – formerly Twinco Romax LLC – 100 Crowell Road

## Gentlemen:

I live on the corner of Victory and MacArthur Drive, two blocks from one of the entrances to Highline Warren/Twinco Romax LLC., and I am requesting a Public Hearing on the permit application.

The permit requests increasing the throughput of raw materials by adding 12 above ground holding tanks. This increases the number of tanks to 18. (If I am correct in reading in a 2019 letter to DNREC that there are 6 existing tanks). These additional tanks increase storage of the raw material chemicals mentioned: methanol, ethanol and propylene glycol, which are volatile, flammable and hazardous.

The permit mentions that the increase of raw material throughput will decrease due to updated "calculation methodologies". Past correspondence also mention "estimates". Estimates are not reliable.

How about the air quality and safety of 300 residents living in Pleasant Hill Estates, Pleasant Hills and Silview that this will affect by the increasing the emission of VOC's/HAP's. Plus this adds to the emission being released into the air by the other companies behind our development. The possibility of on-site chemical spills from the above ground tanks is also a possibility. Weather is another factor – Hurricanes, tornadoes (which are not uncommon to Delaware) definitely increases odds for an "event".

There will definitely be an increase of tractor trailer and supply trucks releasing more diesel fumes in the community. These trucks have caused damage to property and utility lines and should not be using residential streets.
