REQUEST FOR HEARING

I am in receipt of an email from Venessa Karpeh, Senior Legislative Assistant advising the neighborhoods of Silview and Pleasant Hills that a factory in our area is requesting to increase their production to 24/7. (Attached).

We have been fighting with this factory for years, since they snuck in in 2013. I say "snuck" because the notices were mailed to the wrong neighborhood and no one had the opportunity to object. We were completely shocked when the factory opened.

Additionally, attached is a letter from New Castle County Planning Division Manager, to a law firm, indicating that the area is zone LIGHT INDUSTRIAL USE. There is nothing "light" about what this factory is doing.

Since they opened, we average approximately 350 trucks during regular business hours (see attached 30-day period); if this traffic increases our neighborhood will be destroyed, our property values will be in the trash since we will, in effect, be living in an industrial park. We will be unable to live in our homes. Unable to sell them. Our once quiet neighborhood, and the families in it, will be destroyed.

I am requesting a hearing be held so that the citizens can voice their concerns.

The New Castle County Department of Land Use is in receipt of your request for a verification of zoning and use for tax parcel number 07-046.40-129, located at Crowell Road and Harding Avenue, Wilmington, Delaware.

A review of the Official Zoning Map of New Castle County indicates the subject parcel is zoned I (Industrial), which permits a variety of light industrial uses including manufacturing and assembly activities, research and development, storage, warehousing, associated offices and similar uses pursuant to Table 40.03.110 and Section 40.33.270.D of the New Castle County Unified Development Code (UDC). Please be advised that a Certificate of Use must be obtained prior to commencing a new use, and refer to item two, Certificate of Use Application, below.

A Record Minor Land Development Plan for Part of Reserved Industrial Section in Pleasant Hills, Lots 14 & 15 (microfilm 4448) was recorded in the Office of the Recorder of Deeds for New Castle County on April 29, 1977. The approval and recordation of this plan indicate compliance with the zoning and subdivision code requirements in effect at the time. Please be advised that any new construction or changes in use to that shown on the recorded plan may require compliance with current UDC regulations.

PLEASE BE ADVISED THAT THIS ZONING VERIFICATION ONLY VERIFIES THAT THE USE EXISTING OR PROPOSED ON THE SITE AS YOU DESCRIBED IN YOUR ZONING VERIFICATION APPLICATION IS PERMITTED, NOT PERMITTED, OR PERMITTED UNDER LIMITED CIRCUMSTANCES.

THIS VERIFICATION DOES NOT CONSTITUTE A LIMITED USE PERMIT, CERTIFICATE OF USE, BUILDING PERMIT, CERTIFICATE OF OCCUPANCY, OR ANY OTHER PERMIT THAT MAY BE REQUIRED BY THE NEW CASTLE COUNTY CODE BEFORE THE PROPOSED USE MAY COMMENCE.

Any new or change of use in an existing building may require:

- 1. Limited Use Permit Application. If a landowner proposes to institute a new use or expand an existing use on his/her property and such use is classified as a "Limited Use", a review will be undertaken by the Department to determine whether the criteria for such use are met. The landowner must submit a Limited Use Permit Application accompanied by a Site Plan which must be approved prior to the use commencing on the site. Certain uses may require separate applications (i.e. extractive use, power generating facilities, etc.) In general, please see Articles 3 and 31 of Chapter 40 of the New Castle County Code (Unified Development Code or UDC).
- 2. Certificate of Use Application. If a landowner proposes to institute a new use or expand an existing use on his/her property, and intends to utilize an existing building for such use, a review will be undertaken by the Department to determine whether the existing building meets the BOCA Code requirements for such use. The landowner must submit a Certificate of Use Application which must be approved prior to the use commencing in the building. In general, see please Article 2 of Chapter 6 of the New Castle County Code (Buildings and Property Regulations).

Any new or change to existing development (i.e. structures or parking) on the site may require:

- 1. Major or Minor Land Development/Subdivision Plan Application. If a landowner proposes to subdivide his or her property or add more than 1,000 square feet of gross floor area, a review will be undertaken by the Department to determine whether the land development criteria as set forth in the UDC are met. The landowner must submit a Major or Minor Land Development/Subdivision Plan Application which must be approved prior to the development of the site. During the review of the application, the Department may identify other applications, plans, studies, or permits that need to be submitted before development can commence. In general, please see Article 31 of Chapter 40 of the New Castle County Code (Unified Development Code or UDC).
- 2. Parking Plan Application. If a landowner proposes to install a parking area, or to change the existing configuration of an existing parking area, a review will be undertaken to determine whether the parking area adheres to the requirements of the UDC. The landowner must submit a Parking plan Application which must be approved prior to development of the site. In general, please see Articles 3 and 31 of Chapter 40 of the New Castle County Code (Unified Development Code or UDC).
- 3. Building Permit Application/ Sign Permit Application. If a landowner proposes to build, alter, or replace any structure on the site, including but not limited to the mechanical systems within the structure, a review will be undertaken to determine whether the structure is in compliance with Chapter 6 of the New Castle County Code. During the review of the

application, the Department may identify other applications, plans, studies, or permits that need to be submitted before development can commence. Prior to occupancy of the structure, a Certificate of Occupancy must be secured from the Department. In general, please see Chapter 6 of the New Castle County Code (Buildings and Property Regulations).

This summary of land use permit applications is intended only for general informational purposes and is not intended to be inclusive of all the comprehensive requirements contained within the New Castle County Code. Further, the summary does not include any state or federal applications, studies, inspections, or permits that must be secured before a new use or development can occur. Landowners contemplating a change of use or future development are encouraged to engage the services of an attorney, engineer, and/or land surveyor for guidance as to what permits need to be secured prior to a new use or development. General questions regarding the plan review process, Building/Sign Permits or Certificates of Use/Occupancy can be answered by the Department at 395-5400.
