This letter is written in support of the proposed anaerobic digester and expansion of the Bioenergy Innovation Center located in Sussex County. The Wicomico Environmental Trust voices its support of this project and asks DNREC to grant the permits sought by Bioenergy DevCo.

If approved, the Bioenergy Innovation Center's anaerobic digestion facility will process up to a quarter million tons of poultry processing and hatchery waste per year, including the dissolved air flotation (DAF) waste currently produced by Perdue's processing plant. Currently, high-nutrient DAF material is stored by waste management companies in several large, open-top tanks across Delmarva in the Chesapeake Bay watershed. This waste is then spread liberally on local farm fields as a soil amendment of uncertain composition and at rates more consistent with waste disposal than fertilization, and creates runoff into streams and rivers, increasing the nutrient loads in our waterways.

DAF and other poultry waste is a huge problem for Delmarva's poultry industry and residents, and anaerobic digestion offers a technologically more advanced way of handling it. Digestors are proven tools focused on the management of waste without the use of landfills or land application, and offer an obtainable goal of protecting natural resources and the environment. The end material produced by anaerobic digestion will create a dry, odor-free, easily transported product that will substantially improve the water quality of our local tributaries and bays.
