Laws* C.86, pp.291-299(Approved July 1, 1991; the processing of this application will require a fee based on the complexity of the treatment improvements or new construction to be undertaken and is related to the point system established for the classification of wastewater treatment facilities in Section 5 of the State of Delaware Regulations for Licensing Operators of Wastewater Facilities. A separate invoice will be mailed to the applicant indicating the required fee.

5. Public Notification

Pursuant to 7 Del. C., Chapter 60, §6004, an advertisement shall be placed in a newspaper of general circulation in the county(ies) in which the activity is proposed and in a daily newspaper of general circulation through the State, notifying the public that the application has been received by the Department and offering a brief description of the nature of the proposed activity. In accordance with 7 Del. C., Chapter 60, §6004, the cost of such advertisement shall be borne by the applicant. This application will not be considered complete and cannot be processed unless accompanied by an advertising fee in the amount of One Hundred Forty Dollars (\$140.00), payable to the State of Delaware.
