Four people in my community have seen a small airplane flying around our neighborhood and two have seen it spraying the woods behind their homes. My neighbor is certain it was yellow, the others weren't sure. One said it smells like sulfur.

Two of the appellants said it was spraying behind their home regularly. One said it smells like ammonia and rotten eggs. The other said it smells like "cat piss".

A woman who works at a local grocery store said she and a friend saw a yellow airplane spraying fields somewhere near Mountaire and that whatever it was spraying smelled terrible.

A woman who works for a vendor I use told me she knows the pilot. She said DNREC is there when he fills up.

I copied the 6 of the 7 witnesses on this email (two share an email address). I asked them not to respond so you don't get bombarded with emails.
