The Department of Natural Resources and Environmental Control (DNREC), Division of Air Quality (DAQ) will conduct two virtual public workshops on draft amendments to **7 DE Admin. Code 1126 – MOTOR VEHICLE EMISSIONS INSPECTION PROGRAM** and **7 DE Admin. Code 1131 – LOW ENHANCED INSPECTION AND MAINTENANCE PROGRAM.**

The purpose of these workshops is to inform the public about proposed changes to Delaware's Inspection and Maintenance (I/M) Program. Such changes necessitate the update of Regulation 1126 "Motor Vehicle Emissions Inspection Program" and 1131 "Low Enhanced Inspection and Maintenance Program." DNREC will also seek public input on the proposed regulatory changes which includes a waiver cost increase in Sussex County.
