The task of this key stakeholders' workgroup is to help DNREC identify and understand the many issues relative to implementing the Advance Clean Car II program, and to help craft Delaware's plan for achieving the clean air outcomes anticipated by the ACC2 program. Following this, DNREC will take the product of this workgroup through the next step in the regulation adoption process to reach a broader public audience with public workshops (November 15, 16 and 17) and conclude with the holding of a public hearing in early 2023.
