- 7 **DE Admin. Code** 1114, Visible Emissions
- Regulation 1114 controls the emissions of visible air contaminants
- 7 DE Admin. Code 1114 is part of Delaware's State Implementation Plan (SIP)
- States are required to submit the proposed amendments to the Environmental Protection Agency (EPA)

- June 30, 2011 Sierra Club petition to the EPA
- Startup the setting in operation of a process or piece of equipment
- Shutdown the stopping of a process or piece of equipment
- Malfunction the sudden and unavoidable breakdown of process or control equipment

- June 12, 2015, EPA State Implementation Plan Call (SIP Call)
 - State Implementation Plans should not include exemptions for excess emissions during Startup, Shutdown and Malfunction events (SSM)
 - States required to submit SIPs correcting the deficiencies by November 22, 2016
 - 7 DE Admin. Code 1114 is included in the SIP Call

- Delaware proposed the removal of 7 DE Admin. Code 1114 from its State Implementation Plan on November 22, 2016.
- Delaware maintained Regulation 1114 as a "state-only" regulation.

- October 23, 2023, the EPA issued a final rule disapproving Delaware's November 22, 2016, State Implementation Plan Call submittal.
- Today's action is in response to the EPA's disapproval.

Proposed Amendments to 7 DE Admin. Code 1114 "Visible Emissions" (Docket #2023-R-A-0027)

Proposed Language:

1.0 General Provisions

1.3 The provisions of this regulation shall not apply to the start-up and shutdown of equipment which operates continuously or in an extended steady state when emissions from such equipment during start-up and shutdown are governed by an operation permit issued pursuant to the provisions of 2.0 of 7 **DE Admin. Code** 1102.

2.0 Requirements

2.1 No Except as outlined in 2.2, no person shall cause or allow the emission of visible air contaminants or smoke from a stationary or mobile source, the shade or appearance of which is greater than 20% opacity for an aggregate of more than three minutes in any one hour or more than 15 minutes in any 24 hour period. For guideline purposes only, Shade Number 1 of the Ringlemann Smoke Chart coincides with the regulatory limit of 20% opacity, when observing black smoke.

2.2 During the start-up and shutdown of equipment, no person shall cause or allow the emission of visible air contaminants or smoke from a stationary or mobile source, the shade or appearance of which is greater than 40% opacity for more than 6 consecutive minutes in any 1 hour period.
