Notice of Public Hearing

The Department of Natural Resources and Environmental Control (DN-REC), Division of Fish and Wildlife will conduct a public hearing to consider comments from the public on proposed revisions to 7 DE Admin. Code 3900: Wildlife.

The division proposes to make changes to 19 subsections of the regulation that pertain to the management and conservation of wildlife including activities involving hunting, trapping, fishing, nuisance wildlife control work and activities authorized on Division-owned lands.
