<p>The Department of Natural Resources and Environmental Control (DNREC), Division of Climate, Coastal and Energy will conduct a public hearing on Tuesday, July 22, 2025, beginning at 6:00 p.m. to consider comments from the public on the 7 DE Admin. Code 2101 Regulations for State Energy Conservation Code (Docket # 2025-R-CCE-0008.)</p> <p>The objective of revising 7 DE Admin. Code 2101 is to adopt updated versions of the International Energy Conservation Code and the American Society of Heating, Refrigerating and Air-Conditioning Engineers Standards with zero net energy capable amendments.</p> <p>The proposed amendments will be available online beginning July 1, 2025.
