Notice of Public Hearing

The Department of Natural Resources and Environmental Control (DNREC), Division of Parks and Recreation, will conduct a public hearing on Wednesday, August 5, 2026, beginning at 6:00 p.m. to consider comments from the public on proposed changes to the Regulations Governing State Parks (Docket # 2025-R-P-0017).

The proposed changes to the Regulations Governing State Parks (7 DE Admin. Code 9201) include clearer formatting, updated definitions and several rule updates. Key changes address magnet fishing, bait restrictions, 24/7 park operations, surf-fishing procedures, standards for appropriate attire and signage, drug and alcohol rules and a ban on reselling reservations.
