#### DEFINITIONS AS USED IN THIS ENDORSEMENT

**Accident** includes continuous or repeated exposure to conditions which results in bodily injury, property damage, or environmental damage which the insured neither expected nor intended.

Motor Vehicle means a land vehicle, machine, truck, tractor, trailer, or semitrailer propelled or drawn by mechanical power and used on a highway for transporting property, or any combination thereof.

**Bodily Injury** means injury to the body, sickness, or disease to any person, including death resulting from any of these.

Property Damage means damage to or loss of use of tangible property.

The insurance policy to which this endorsement is attached provides automobile liability insurance and is amended to assure compliance by the insured, within the limits stated herein, as a motor carrier of property, with Sections 29 and 30 of the Motor Carrier Act of 1980 and the rules and regulations of the Federal Motor Carrier Safety Administration (FMCSA).

In consideration of the premium stated in the policy to which this endorsement is attached, the insurer (the company) agrees to pay, within the limits of liability described herein, any final judgment recovered against the insured for public liability resulting from negligence in the operation, maintenance or use of motor vehicles subject to the financial responsibility requirements of Sections 29 and 30 of the Motor Carrier Act of 1980 regardless of whether or not each motor vehicle is specifically described in the policy and whether or not such negligence occurs on any route or in any territory authorized to be served by the insured or elsewhere. Such insurance as is afforded, for public liability, does not apply to injury to or death of the insured's employees while engaged in the course of their employment, or property transported by the insured, designated as cargo. #### **Driver Safety Rules**

- The use of a company vehicle while under the influence of intoxicants and other drugs is forbidden and is sufficient cause for discipline, including dismissal.
- No driver shall operate a company vehicle when their ability to do so safely has been impaired by illness, fatigue, injury, or prescription medication.
- All drivers and passengers operating or riding in company vehicles must wear seat belt, even if air bags are available.
- No unauthorized personnel (hitch hikers) are allowed to ride in company vehicles.
- Drivers are responsible for the security of company vehicles assigned to them. The vehicles
  engine must be shut off, ignition keys removed, and doors locked whenever it is left unattended.
  If left with a parking attendant, only the ignition key is to be left.
- Head lights shall be used half hour after sunset and half hour before sunrise, or during inclement weather or at any time when a distance of 500 feet ahead of the vehicle cannot be seen clearly.
- All other state laws, local laws, or DOT Motor Carrier Safety Regulations must be obeyed.

### **Defensive Driving Rules**

- Drivers are required to maintain a safe following distance at all times. To estimate your following distance, pick a stationary object ahead of you. As the vehicle in front of you passes through the object, begin counting 1001, 1002, 1003, etc. until you reach the same object. This counts the number of seconds between you and the vehicle ahead of you.
- Drivers of passenger vehicles should keep a two second interval between their vehicle and the
  vehicle ahead of them. During slippery conditions this should increase to at least four seconds.
- Drivers of heavy trucks should keep a minimum of three seconds intervals when no caring cargo, and four when loaded.
- Must yield the right of way all traffic control signals. Pedestrian and bicycles have the right of way/
- Avoid blind spots; attempt to maintain eye contact with other drivers.

- Must honor speed limits. In adverse driving conditions reduce to a safe operating speed that is consistence with weather and road conditions.
- Turn singles must be used to show where you are heading.
- Be alert of other vehicles, pedestrians and bicyclist when approaching intersections. Never speed through intersections on a caution light.
- When waiting to make left turns, keep your wheels facing straight, if rear-ended you will not be pushed into the lane or oncoming traffic.
- When stopping behind another vehicle, leave enough space so you can see the rear wheels or the
  car in front of you.
- Avoid backing where possible, but when necessary, keep the distance traveled to a minimum.
   Check behind the vehicle, operators should walk around their vehicle before backing up or have someone guide you.

#### What To Do In Case Of An Accident

In an attempt to minimize the result of an accident, the driver must prevent further damages or injuries and obtain all pertinent information and repot it accurately.

- · Call for medical aid if necessary
- Secure accident scene-pull onto shoulder or side or road, redirect traffic, set up road flares/reflectors
- Call the police
- Record names and addresses or driver, witnesses and occupants of the other vehicle and any
  medical personnel who may arrive at the scene
- · Complete vehicle accident form, draw a diagram of accident
- Do not discuss the accident with anyone but the police, DO NOT accept responsibility, and do not
  argue with anyone.

#### Vehicle Maintenance

Proper vehicle maintenance is a basic element of any fleet safety program, not only to ensure a safe, road worthy vehicle, but also to avoid costly repair expenses and unexpected breakdowns.

- Registration and inspection is the responsibly of the assigned driver
- Interior and exterior should be cleaned regularly to help maintain its good appearance for you and your company

#### Vehicle Fleet Safety Policy

The purpose of this policy is to ensure the safety of those individuals who drive company vehicles and to provide guidance on the proper use of company fleet vehicles. Vehicle accidents are costly to our company, but more importantly, they may result in injury to you or others. It is the driver's responsibility to operate the vehicle in a safe manner and to drive defensively to prevent injuries and property damage. As such, employers endorse all applicable state motor vehicle regulations relating to driver responsibility. The employer expects each driver to drive in a safe and courteous manner pursuant to the following safety rules. The attitude you take when behind the wheel is the single most important factor in driving safely. Fleet Administration, Security, and the Fleet Safety Committee are responsible for general administration of this policy.

#### **Driver Eligibility**

- Company vehicles are to be driven by authorized employees only, except in case of repair testing by a mechanic.
- Any employee who has a driver's license revoked or suspended shall immediately notify the Security and Fleet offices by 9 a.m. eastern time the next business day, and immediately discontinue operation of the company vehicle. Failure to do so may result in disciplinary action, including termination of employment.
- All accidents in company vehicles, regardless of severity, must be reported to the police and to
  the Security and Fleet offices. Accidents are to be reported immediately (from the scene, during
  the same day, or as soon as practicable if immediate or same day reporting is not possible).
  Accidents in personal vehicles while on company business\* must follow these same accident
  procedures. Accidents involving the employee's personal injury must be reported to Human
  Resources for Worker's Compensation purposes. Failing to stop after an accident and/or failure
  to report an accident may result in disciplinary action, up to and including termination of
  employment.
- Drivers must report all ticket violations received during the operation of a company vehicle, or while driving a personal vehicle on company business\*, within 72 hours to the Security and Fleet offices.
- Motor Vehicle Records will be obtained on all drivers prior to employment and no less than
  every six months. A driving record that fails to meet the criteria stated in this policy, or is
  considered to be in violation of the intent of this policy by the Fleet Safety Committee, will result
  in a loss of the privilege of driving a company vehicle.
- \* Company business is defined as driving at the direction, or for the benefit, of employer. It does not include normal commuting to and from work.

# Frequently Asked Questions: Commercial Motor Vehicle (CMV) Hand-Held Mobile Telephone Ban

1. Q: What is the effective date of the Mobile Telephone rule?

A: The effective date of the rule is January 3, 2012.

2. Q: Are wired or wireless earpieces allowed?

A: Yes. Hands-free use of a mobile telephone is allowed using either a wired or wireless earpiece, or the speakerphone function of the mobile telephone. Wireless connection of the mobile telephone to the vehicle for hands-free operation of the telephone, which would allow the use of single-button controls on the steering wheel or dashboard, would also be allowed.

3. Q: Are CMV drivers allowed to use push-to-talk mobile communications equipment while driving?

A: Yes. Provided the driver does not reach for, dial, or hold the actual mobile telephone in his/her hand while driving and the driver is able to touch the button needed to operate the push-to-talk feature from the normal seated position with the safety belt fastened. Generally, the use of this type of communication equipment does not require drivers to take their eyes off of the forward roadway because the button used to enable the driver to communicate can be operated from the normal seated position with the safety belt fastened. For example, if the mobile phone is mounted in a cradle or similar device near the driver, or there is a remote push-to-talk button near the vehicle controls to allow the driver to communicate without reaching for, dialing, or holding the actual mobile telephone in his/her hands while driving, the equipment may be used.

4. Q: Are holders of a commercial driver's license (CDL) subject to the regulation only when driving a CMV, as defined in 49 CFR 383.5, or any vehicle?

A: CDL holders are subject to the Federal rule only when driving a CMV.

5. Q: What drivers are covered by the Federal rule: intrastate or interstate? CDL holders? All CMVs?

A: The rule covers both drivers of CMVs in interstate and intrastate commerce (vehicles with a GVWR or CGVWR greater than 10,000 pounds). Also drivers who operate a vehicle transporting a quantity of hazardous materials requiring placarding under 49 CFR Part 172 or any quantity of a material listed as a select agent or toxin in 42 CFR part 73. If a CMV driver is employed by the State or a political subdivision of the State (e.g., county, city, township, etc.), FMCSA safety regulations (part 382, 391, 392, 393) apply, even if the driver is only engaged in intrastate transportation.

#### 6. Q: What is required of the employer in terms of company policy or training?

A: The rule does not require motor carriers to establish written policies in terms of company policy or training programs for their drivers. However, employers are prohibited from allowing or requiring their drivers to use hand-held mobile phones. A motor carrier may establish policies or practices that make it clear that the employer does not require or allow hand-held mobile telephone use while driving a CMV in interstate commerce. The carrier is responsible for its drivers' conduct.

#### 7. Q: Is dialing a phone number allowed under this rule?

A: No dialing a mobile telephone while operating a CMV in interstate or intrastate commerce is prohibited by the rule. A driver can initiate, answer, or terminate a call by touching a single button on a mobile telephone, earpiece, steering wheel, or instrument panel – comparable to using vehicle controls or instrument panel functions, such as the radio or climate control system.

#### 8. Q: Can a driver reach for a mobile telephone even if he/she intends to use the handsfree function?

A: No. In order to comply with this rule, a driver must have his or her mobile telephone located where the driver is able to initiate, answer, or terminate a call by touching a single button while the driver is in the seated driving position and properly restrained by a seat belt. If the mobile telephone is not close to the driver and operable while the driver is restrained by properly installed and adjusted seat belts, then the driver is considered to be reaching for the mobile phone, which is prohibited by the rule.

#### 9. Q: Are tow trucks exempt?

A: No. The operations of a tow truck that meets the definition of a CMV are not exempt. Tow trucks, however, are exempt when responding to police emergencies in accordance with 49 CFR 390.23(a)(3).

# Mobile Phone Restrictions Fact Sheet

#### New Mobile Phone Restriction Rule For Commercial Motor Vehicle Drivers

# Overview and Background

A new FMCSA rule restricts the use of all hand-held mobile devices by drivers of commercial motor vehicles (CMVs). This rulemaking restricts a CMV driver from holding a mobile device to make a call, or dialing by pressing more than a single button. CMV drivers who use a mobile phone while driving can only use a hands-free phone located in close proximity.

Research commissioned by FMCSA shows that the odds of being involved in a safety-critical event (e.g., crash, near-crash, unintentional lane deviation) are 6 times greater for CMV drivers who engage in dialing a mobile phone while driving than for those who do not. Dialing drivers took their eyes off the forward roadway for an average of 3.8 seconds. At 55 mph (or 80.7 feet per second), this equates to a driver traveling 306 feet, the approximate length of a football field, without looking at the roadway!

#### What Is The Definition Of Using A Mobile Telephone?

The use of a hand-held mobile telephone means:

- Using at least one hand to hold a mobile phone to make a call;
- Dialing a mobile phone by pressing more than a single button; or
- Reaching for a mobile phone in a manner that requires a driver to maneuver so that he or she is
  no longer in a seated driving position, restrained by a seat belt.

### What Does This Rule Mean To Drivers And Carriers?

- Fines and Penalties Using a hand-held mobile phone while driving a CMV can result in driver disqualification. Penalties can be up to \$2,750 for drivers and up to \$11,000 for employers who allow or require drivers to use a hand-held communications device while driving.
- Disqualification Multiple violations of the prohibition of using a hand-held mobile phone while
  driving a CMV can result in a driver disqualification by FMCSA. Multiple violations of State
  laws prohibiting use of a mobile phone while driving a CMV is a serious traffic violation that
  could result in a disqualification by a State of drivers required to have a Commercial Drivers
  License.
- What are the risks? Using a hand-held mobile phone is risky because it requires the driver to
  reach for and dial the phone to make a call. Reaching for a phone out of the driver's immediate
  area is risky as well as dialing because these actions take the driver's eyes off the roadway.

The rule applies to drivers operating a commercial motor vehicle on a roadway, including
moving forward or temporarily stationary because of traffic, traffic control devices, or other
momentary delays.

A mounted phone is acceptable as long as it is mounted close to the driver.

Impact on Safety Measurement System (SMS) Results - Violations negatively impact SMS results, and they carry the maximum severity weight.

### Compliance

Make sure the mobile telephone is within close enough proximity that it is operable while the driver is restrained by properly installed and adjusted seat belts.

· Use an earpiece or the speaker phone function.

Use voice-activated dialing.

Use the hands-free feature. To comply, a driver must have his or her mobile telephone located
where he or she is able to initiate, answer, or terminate a call by touching a single button. The
driver must be in the seated driving position and properly restrained by a seat belt. Drivers are
not in compliance if they unsafely reach for a mobile phone, even if they intend to use the handsfree function.

# No Texting Rule Fact Sheet

# Overview and Background

FMCSA has published new rules that restrict texting and the use of hand-held mobile phones by truck and bus drivers while operating a commercial motor vehicle (CMV).

Research commissioned by FMCSA shows the odds of being involved in a safety-critical event (e.g., crash, near-crash, unintentional lane deviation) are 23.2 times greater for CMV drivers who text while driving than for those who do not. Texting drivers took their eyes off the forward roadway for an average of 4.6 seconds. At 55 mph, this equates to a driver traveling 371 feet, or the approximate length of a football field (including the end zones)—without looking at the roadway!

### What Exactly Is "Texting"?

Texting means manually entering text into, or reading text from, an electronic device.

Texting includes (but is not limited to), short message services, e-mailing, instant messaging, a command or request to access a Web page, pressing more than a single button to initiate or terminate a call using a mobile telephone, or engaging in any other form of electronic text retrieval or entry, for present or future communication.

#### What Does This Rule Mean To You?

Fines and Penalties - Texting while driving can result in driver disqualification. Penalties can be up to \$2,750 for drivers and up to \$11,000 for employers who allow or require drivers to use a hand-held communications device for texting while driving.

Disqualification - Multiple convictions for texting while driving a CMV can result in a driver disqualification by FMCSA. Multiple violations of State law prohibiting texting while driving a CMV that requires a CDL is a serious traffic violation that could result in a CDL driver being disqualified for up to 120 days.

What are the risks? - Texting is risky because it causes the driver to take his/her eyes off the roadway. Dispatching devices that are part of a fleet management system can be used for other purposes, but texting on a dispatching device is indistinguishable from texting on another text-capable device, and is therefore prohibited.

Impact on Safety Measurement System (SMS) Results - Violations negatively impact SMS results, and they carry the maximum severity weight.

Simply do not type or read a text message while driving a CMV!

# **Distracted Driving Policy**

#### NO TEXTING WHILE DRIVING

All CMV drivers are prohibited from texting while driving. Texting means manually entering alphanumeric text into, or reading text from, an electronic device. This includes, but not limited to, short message service, emailing, instant messaging, a command or request to communication using a mobile phone or engaging in any other form of electronic text retrieval or entry, for present or future communication.

# DO NOT TYPE OR READ A TEXT MESSAGE WHILE DRIVING USE OF MOBILE PHONES IS RESTRICTED FOR CMV DRIVERS

This rule restricts a (CMV) Commercial Vehicle Driver from reaching for or holding a mobile phone to conduct a voice communication, as well as dialing by pressing more than a single button. CMV drivers who use a mobile phone while driving can only operate a hands-free phone located in close proximity. In Short, the rule prohibits unsafely reaching for a device, holding a mobile phone, or pressing multiple buttons.

# How can you, as a driver, use a mobile phone and still obey the rules?

- Locate the mobile phone so it is operable by the driver while restrained by property adjusted seat belts.
- · Utilize an earpiece or the speaker phone function.
- Use voice-activated or one-button touch features to initiate, answer, or terminate a call.

# What happens if a driver is caught using a hand-held phone or texting while driving?

The FMCSA rule imposes sanctions for driver offenses, including civil penalties up to \$2,750 and driver disqualifications for multiple offenses.

Grady & Sons prohibits all drivers from texting and using a hand-held mobile phone while driving and failure to follow such rules will result in disciplinary actions.

If you get a text from anyone while driving do not answer the text while driving. Wait until you are not driving to answer texts. Thank you for your cooperation! Your safety is important!

#### SPEEDING POLICY

Section 392.2 of the Federal Motor Carrier Safety Regulations requires that every motor vehicle be operated in accordance with the laws, ordinances and regulations of the jurisdiction in which the vehicle is being operated.

Section 392.6 of the Federal Motor Carrier Safety Regulations restricts the operation of any motor vehicle between points in such period of time as would necessitate the vehicle being operated at speeds greater than those prescribed by the jurisdiction in or through which the vehicle is being operated.

It is the policy of this company to the Federal Motor Carrier Safety Regulations. Speed shall never be faster than the existing laws permit. Consideration should be given to off road, traffic and weather conditions.

The meaning of the above section is simply- NO SPEEDING!

If a drivers log indicates traveling 565 miles in 10 hours, the entire distance covered by a 55 mph speed limit, the obvious conclusion is that the driver was speeding. The driver may be held accountable under the Federal requirements set forth above.
