Driver Training & Safety Procedures

- 1) All drivers must complete an application for employment prior to being hired.
- 2) An inquiry is made into each driver's driving records for the past 3 years in every state which
- 3) Copy of each driver's current license to prove that they hold at a minimum of a Class B CDL for straight trucks and a Class A for any drivers that will operate trucks with any kind of trailer. No driver will be considered for a driving position without a minimum of a Class B CDL.
- 4) Each new driver is trained on our company's requirements for pre-trip inspections, load securing, proper method for setting down trailers/cans and post trip report. Each truck contains an inspection report which creates a carbon copy, the original remains in the truck and the carbon copy is turned into the main office. Each driver is expected to maintain this inspection book on a daily basis or as the truck is used. Drivers are expected to have a strong understanding of the types of Solid Waste the company is permitted to transport. Drivers are expected to have a firm understanding of the various types of solid waste. Driver must assess and understand safe procedures for dropping off and picking up containers, this is critical to maintaining safe operations of the vehicle. Drivers must not pick up cans that have been overfilled, this can result in damage to the vehicle, and furthermore, it can create an unsafe situation for any people or vehicles nearby should the lifting mechanism fail due to the excessive weight. Overfilled cans also present a serious hazard on the road because the tarp, in the case of a roll off-container, may not cover the load properly causing debris to fly off the truck while en route to disposal facility.
- 5) All drivers are trained and are expected to understand the procedure for reporting an accident or emergency of any kind directly to one of the Owners. All drivers have the cell phone numbers of both owners so as to be able to contact one or both of them immediately following an accident.
- 6) Drivers are to be familiar with spill control plan and the tools being used in a spill control situation. Also, a list of emergency contact information is kept in each truck and each driver is required to know where to find such information. Information such as emergency reporting numbers in NJ & DE. - 7) Each year, typically at the end of each calendar year, a driver abstract is pulled for each driver to check each driver's driving record.

- 9) A complete file is kept with up to date medical examiners card, copy of valid CDL license, driver abstract and any other information the company deems necessary or important.
- 10) The company maintains a 3 strike rule for any driver found in violation of any of the requirements or rules set forth by South Jersey Recycling LLC. A 3rd violation will result in permanent firing.
