

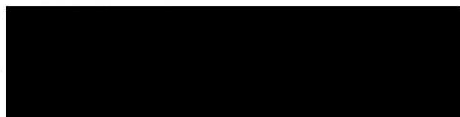

AEG Environmental has been an environmental management contractor in Maryland, Virginia, Pennsylvania, Delaware, and Washington DC since 1995. We currently hold the following permits and certifications:

In the 30+ years that AEG has been doing business the Company has received nine Notice of Violations (NOV) from regulatory agencies. In May 2004 the Pennsylvania Department of Environmental Protection (DEP) issued an NOV for transporting hazardous waste on an erroneous manifest. The reason for this NOV was that one of our drivers had incorrectly dated a waste manifest and had miscounted a particular line item quantity by one.

In May of 2007, July of 2008, October of 2016 and October of 2018, AEG filed our quarterly hazardous waste report to the Pennsylvania DEP late. In January 2017, AEG mistakenly omitted the October 2016 NOV from our Residual Waste Permit Application. The DEP issued a Notice of Violation for these errors. No further action was taken against AEG in any of these cases.

In October of 2007, AEG was issued a Notice of Violation from the State of Connecticut Department of Environmental Protection. The NOV stated that AEG had transported hazardous waste in Connecticut without obtaining a permit. This was an error. AEG had transported waste for a generator located in Connecticut; however, all the waste was in Maryland and disposed of in Pennsylvania. No waste had ever entered or been transported in Connecticut. Upon explanation, the Connecticut DEP closed the NOV, and no further action was taken against AEG.

In February of 2012 AEG was issued a Notice of Violation from the Pennsylvania DEP. On this occasion a drum of non-hazardous waste in our vehicle failed and caused a spill. AEG responded to the spill site with a hazardous materials response team and remediated the spill area. There was no environmental impact from this incident and the NOV is closed.

Other than these instances, AEG has no other Enforcement Actions in our 28+ year compliance history.

Accident includes continuous or repeated exposure to conditions or which results in bodily injury, property damage, or environmental damage which the insured neither expected nor intended.

Motor Vehicle means a land vehicle, machine, truck, tractor, trailer, or semitrailer propelled or drawn by mechanical power and used on a highway for transporting property, or any combination thereof.

Bodily Injury means injury to the body, sickness, or disease to any person, including death resulting from any of these.

Property Damage means damage to or loss of use of tangible property.

Environmental Restoration means restitution for the loss, damage or destruction of natural resources arising out of the accident; discharge, dispersal, release or escape into or upon the land, atmosphere, watercourse, or body of water, of any commodity transported by a motor carrier. This shall include the cost of removal and the cost of necessary measures taken to minimize or mitigate damage to human health, the natural environment, fish, shellfish and wildlife.

Public Liability means liability for bodily injury, property damage and environmental restoration.

The insurance policy to which this endorsement is attached provides automobile liability insurance and is amended to assure compliance by the insured, within the limits stated herein, as a motor carrier of property, with Sections 29 and 30 of the Motor Carrier Act of 1980 and the rules and regulations of the Federal Motor Carrier Safety Administration (FMCSA).
