Applicant shall contact DelDOT Traffic Management Center for proposed travel lane closures prior to commencement of work 1-302-659-4600. Applicant is not authorized to perform lane closures between 6:00am to 9:00am or between 3:00pm to 7:00pm.

Applicant is solely responsible for ensuring traffic control devices are set up in accordance with Delaware MUTCD (Delaware Manual on Uniform Traffic Control Devices). Applicant is solely responsible for identifying the correct maintenance of traffic "typical application" in accordance with MUTCD.

All work shall be performed in accordance with DelDOT Utilities Manual, DelDOT Standard Specifications and DelDOT Standard Construction Details. Applicant shall use only the traffic control devices as listed on DelDOT website for "Approved Products List".

Applicant is responsible for ensuring all temporary traffic stops, rolling road blocks and pedestrian detours are in accordance with Delaware MUTCD. Notify DelDOT Inspector if proposing to use escorted pedestrian flagger operations rather than pedestrian detours.

Applicant shall provide uniformed law enforcement officer at all signalized intersections impacted by this work, to assist with traffic control.

Applicant is responsible for identifying the location of all stormwater pipes within right-of-way or easements in the vicinity of excavation prior to commencement of work. DelDOT GIS map shall not be considered to be an accurate representation of existing stormwater pipe locations. Applicant shall repair all stormwater pipe damaged during excavation under this Permit. All costs to repair the damaged pipe and drainage structures shall be the responsibility of the Applicant.

Applicant shall coordinate with DelDOT Inspector and DelDOT Safety Officer prior to commencement of work, to coordinate lane closure requirements.
