To Whom It May Concern:

The following is the operations plan for the management of sewage disposal activities in relation to the State of Delaware. In cases of spills that our vacuum truck operators encounter on the job, it is their responsibility to notify all appropriate parties depending on the size of the spill. All of our trucks are equipped with spill protection kits that include containment pools and absorption rings and pads. In the event of a spill, DNREC Emergency Response Unit will be contacted and notified as follows:

- Call 911 for immediate threats.
- Contact the DNREC Emergency Response Team (24/7) via telephone to report spills of all materials.
- Provide the chemical name, whether it is an Extremely Hazardous Substance (EHS), the estimated quantity released, and the time/duration of the release.
- Provide the medium or media into which the release occurred.
- Provide any known or anticipated acute or chronic health risks associated with the emergency and, where appropriate, obtain advice regarding medical attention necessary for exposed individuals.
- Obtain proper precautions to take as a result of the release, including evacuation.
- Provide the name and telephone number of the person or persons to be contacted for further information.
- Provide a written follow up regarding the incident as advised.

Spills that happen to occur in a facility where work is being performed, we would take similar actions as noted above, to include following the facilities spill protection policies and procedures if available.

After completion of cleanup, a full written report will be kept on file in the office for 5 years, available to DNREC upon request. Following the event, business administration will note all safety concerns and disseminate modified procedures and processes to all employees to help prevent future spills. If a spill occurs as part of a mechanical failure of a vehicle, the leak will be investigated and mitigated through repair, and the details of the source of the problem and the fix for it will be documented along with the full incident report. All other similar vehicles will be inspected for the same failure, corrected as needed and documented as such.

Vacuum trucks are cleaned out on a quarter-by-quarter basis to remove any residual waste from the trucks. This is conducted at minimum on a quarterly basis and more frequently when needed, after regular inspections are performed. This is done at approved locations suitable to contain the waste. All work performed by these vacuum trucks are tracked through our customer management system and kept on record. We carry and dump septage and grease separately and only at authorized dumping locations which are tracked on facility dumping logs which are kept on file at our office. All whereabouts of our vehicles are also able to be tracked through our GPS system at any time.

Our normal hours of operations are generally 8:00AM to 4:30PM, Monday-Friday. However, we also perform 24/7 emergency and priority services which requires our vehicles to operate outside of those hours on a as needed basis.

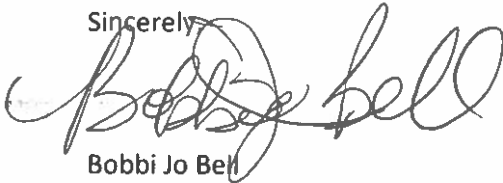

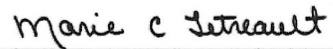

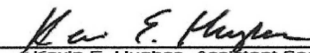
