1. TYPE OF ACTION AND THE REGULATION NUMBER AND NAME:

Amendments to DE Admin. Code 1203, Reporting of a Discharge of a Pollutant or Air Contaminant.

2. PURPOSE OF ACTION:

The Division of Waste and Hazardous Substances is proposing to amend regulatory requirements for reporting the discharge of a pollutant or an air contaminant as mandated in 7 **Del.C.**, Section 6028. The primary reason for amending this regulation is to point a person to the EPA List of Lists to reflect an accurate chemical list and reportable quantities for those chemicals. Currently, reporting requirements and reportable quantities are provided through the use of a table in the regulation that identifies Delaware specific chemicals and reportable quantities as well as federal chemicals and reportable quantities listed under CERCLA, Section 112(r) of the Clean Air Act (CAA), or Section 311 of the Clean Water Act of 1980.

However, the table published under this regulation is static and has not been updated since 2004. Moreover, when chemicals or amounts of chemicals are added to any federal list identified in the previous paragraph, those changes are not reflected in this regulation.

Amending the table in DE Admin. Code 1203 by removing federal chemicals and associated reportable quantities and pointing the regulated community to the EPA List of Lists that will provide a current list of chemicals and reportable quantities is more efficient and will result in a more effective regulation. Additionally, requiring the Department to review Delaware specific chemicals and reportable quantities is appropriate to account for any regulatory or programmatic changes within the Department.
