Amendments to DE Admin. Code 1201, Accidental Release Prevention Regulation

2. PURPOSE OF ACTION:

The purpose of this action is to adopt federal regulatory amendments required to maintain a delegated authorized program. The planned revisions include updating the regulations to adopt required federal rules, including the following:

- (1) Program Levels 2 and 3 emergency planning coordination activities
- (2) Worst case release scenario analysis
- (3) Hazard review
- (4) Operating procedures
- (5) Compliance audits
- (6) Third party audits
- (7) Incident investigation
- (8) Employee participation
- (9) Process hazard analysis
- (10) Hot work permit
- (11) Applicability

Additionally, the amendments will update regulatory requirements specific to Delaware's Accidental Release Prevention program and will include corrections to typographical and grammatical errors and corrections to ensure consistency with the *Delaware Administrative Code Drafting and Style Manual*.

Title 7 **Del.C.** Ch. 77, Extremely Hazardous Substances Risk Management Act, and 40 Code of Federal Regulations (CFR) Part 68, Chemical Accident Provisions.
