2023 Overall Program Costs

² Items covered under the "Contractual" category include: Fleet charges (vehicle rental), building rent, utilities, vendor payments, temp services, and the upkeep of some air monitoring equipment.



³ Items covered under "Additional Support Services" include: Information Technology (\$21,705.57), the Environmental Crimes Unit (\$502,792.59) and Office of the Secretary Support (\$22,250.00).

2023 Overall Program Costs Considerations

Note: While the state operates on a fiscal year (FY) basis (July 1 - June 30), the Title V fees are billed and spent on a calendar year (CY) basis. Consequently, some "Additional Support Services" costs, charged by other programs/organizations, may be expended outside of CY 2023 cost factors.

Note: In 2020 and 2021 DAQ was able to supplement ECU cost with another funding source. In 2019 (and other previous years) ECU costs (\$459K) are comparable to 2023 ECU costs (\$502K). The increase noted in 2022 is due to ECU salary increases.

 - These facilities received 2% late fees applied to the account for each delinquent month.




2023 Title V Revenue

Estimation Factors

- Actual fees billed for 2024 (include overdue fees from previous year).
- Actual 2024 salary expenses with an average staffing level of 98%.
- For additional expense categories, the five-year average plus an additional 2.5% cost of living expense used in 2024.

Note: The average Division staffing level in CY 2023 was 87%.

- During CY 2023, five full-time employees separated and twelve full-time employees were hired.
- AQ received three additional authorized positions under the planning section in FY24 budget.
- Two of these positions were approved for hire at the end of CY23.
- All three positions are funded under grants and general funds.
- CY2023 AQ authorizations were increased from 60 to 62 full time positions.



 - 2024-2026 Fee schedule effective 1/1/2024
- 2024-2026 Title V Fee Structure:
 - ☐ User and Base Fee remain the same
 - Program Fee reduced to 5% of the user and base fee
- The primary factors for decreasing program costs include:
 - □ Reduce the Title V Carryover balance (\$4.3M on 12/31/22)
 - ☐ Target = six-months of operating funds (\$2,000,000)
