

Elevate Appliances

Overview

- If you have appliances in the basement, they may be at risk during flood events. Elevate the appliances onto platforms to avoid replacement/repair costs.
- Appliances include:
 - o Refrigerator
 - Chest freezer
 - Washing machine
 - o Dryer
- When elevating appliances, new outlets and new washing machine and dryer hook-ups may need to be installed.
- Elevate the washer and dryer near existing plumbing to reduce costs.
- If replacing appliances, upgrade to more efficient appliances, if possible.
- The cost of elevating appliances depends on the type of building and the location of the appliances.
- While elevating appliances, consider elevating important personal items/valuables as well.
- This strategy will not protect the structure from flooding but will help reduce flooding associated costs.





Key Takeaways

During flood events, flood water inside the building can damage appliances.

Additionally, appliances may dislodge and float during flooding events, which can cause more damage inside the structure.

To avoid replacement or repair costs related to flood damaged or destroyed appliances, the appliances can be elevated onto platforms.
