1. **BMP Construction Review Checklists Updated**

The DNREC Sediment and Stormwater Program has released new and revised regulatory guidance documents for public review. The documents support the Sediment and Stormwater Regulations ([7 DE Admin. Code 5101](#)), as set forth at 7 Del.C. §4006(h) and (i).

The existing Post Construction Stormwater Best Management Practices (BMP) Construction Review Checklists have been revised and additional checklists have been developed, along with a user guide. The BMP Construction Checklists are provided to assist construction reviewers during post-construction stormwater BMP construction.

The DNREC Sediment and Stormwater Program hereby provides notice of the revised regulatory guidance documents, pursuant to 7 Del.C. §4006(i), which incorporates the provisions of 7 Del.C. §6004. A public hearing will NOT be held unless the Secretary receives a meritorious request for a hearing within 15 days of the date of this notice, ending February 16, 2023. A request for a public hearing shall be in writing and show familiarity with the regulatory guidance document and provide a reasoned statement of the regulatory guidance document's probable impact.

2. **CCR Training - Spring 2023 Registration is Open**

Pre-registration for the Sediment and Stormwater Program 2023 Certified Construction Reviewer course is open until February 19th at 11:59 pm. To pre-register, complete and submit the online [CCR Pre-registration Form](#).

Completion of the Contractor Training Program (Blue Card Course) is a prerequisite for pre-registering for the CCR Course. If you have not completed the Contractor Training Program, refer to <https://de.gov/ssptraining> for further training and registration information.

The CCR course will be held virtually over three 4-hr class sessions via the Microsoft Teams online platform. In addition, a half-day in-person field trip is required. To become certified, participants must attend all virtual class sessions and one field trip, submit a CCR construction review report based on the field trip, and complete an exam with a minimum score of 80%.

The CCR course is scheduled for consecutive Thursdays in March 2023:

- March 2, 2022 (AM)
- March 9, 2022 (AM)
- March 16, 2022 (Field Trips) (AM or PM)
- March 23, 2022 (AM)

Payment is not being accepted at this time. The payment process, along with additional course information, will be provided after pre-registration. If you cannot attend all sessions, please do not pre-register. No refunds will be issued after payment is made. Formal registration and payment will only be available from February 13th to February 24th for participants who have confirmed pre-registration status.

Class size and participants per company are limited. If eligible, pre-registration and field trip assignments will be approved on a first-come, first-served basis. When limits are reached, names will be added to the waitlist with the potential of participation.

3. New eNOI User Guide

The DNREC Sediment and Stormwater Program has developed a new [Electronic Notice of Intent \(eNOI\) Management User Guide](#) for obtaining coverage under the Delaware Construction General Permit (CGP). This guide has been created to help users complete the workflows associated with creating an account and managing an eNOI for a permit: NOI, Co-permittee, and NOT submissions. Each section includes a short video that directs users through the workflow along with updated navigation throughout the guide.
