## 1. NPDES Construction General Permit Renewals

Under section C.6 of the Delaware NPDES Construction General Permit (CGP), a fee of \$195 is assessed annually to Notices of Intent (NOI) to maintain permit coverage. NPDES CGP coverage is required for those projects disturbing one (1) or more acres until a Notice of Termination (NOT) is submitted and confirmed by DNREC or the relevant Delegated Agency. This confirmation requires:

- A) Compliance with all aspects of the Plan as per 7 DE Admin. Code 5101 Sediment and Stormwater Regulations,
- B) Approval of Post-construction Verification Documents (PCVD) demonstrating that permanent stormwater management measures have been constructed per the approved Plan and regulations, and,
- C) Achievement of final stabilization as defined in Part 1.G. of the CGP.

Currently, invoices are being mailed to the listed owner of all open NOIs. **Payment of the fee is due by July 31, 2025, to maintain permit coverage.** Failure to submit payment of the renewal fee by the due date will cause the permit coverage to expire.

Continuing regulated activities under the Delaware NPDES CGP without valid permit coverage constitutes a violation of the Clean Water Act (33 USC §1251 et seq. and 40 CFR §122.26), Delaware NPDES CGP Permit No. DE 0051268, 7 DE Admin. Code 7201 Section 9.2, Regulations Governing the Control of Water Pollution - Special Conditions for Stormwater Discharges from Construction Activities, 7 Del.C. Ch. 60 Environmental Control, 7 DE Admin. Code 5101 Sediment and Stormwater Regulations, and 7 Del.C. Ch. 40 Erosion and Sedimentation Control. Violators may face fines imposed by the Delaware Department of Natural Resources and Environmental Control and the US Environmental Protection Agency.

## 2. 2025 CCR Recertification Course

CCR recertification is for CCRs whose certification will expire at the end of 2025 and would like to continue their certification. This eight-hour course highlights any changes in the Sediment and Stormwater Program and Regulations along with newer approaches to stormwater management. The 2025 CCR recertification will consist of two four-hour online webinar sessions using a virtual platform (MS Teams), held on **Thursday, October 23<sup>rd</sup> and Thursday, October 30<sup>th</sup> 2025** from 8:00 AM until noon each day. Eligible individuals will be notified this summer by DNREC's Division of Watershed Stewardship by email by the end of July.

As of 2021, the Contractor Training Program (Blue Card) certification is a prerequisite for all CCR certifications. This training is available online at the Delaware Learning Center. All CTP certifications obtained prior to 2020 are no longer valid.
