Meeting Notes

Welcome and Introductions

All members introduced themselves and their role in their respective agency

Presentation - Climate Change and the Role of Climate Officers in Delaware

- Susan Love, DNREC, provided a presentation that reviewed climate change in Delaware and the role of Climate Officers. Brief highlights are as follows:
 - Overview of climate change in Delaware
 - DE sectors producing most emissions: transportation, industry, electricity generation
 - o Increased temps, more frequent/intense storms, Sea Level Rise
 - Impacts on Delaware include infrastructure damage, energy system stress, land loss, cost increases, and health risks
 - State agency operations also contribute to emissions
 - o Climate Change Solutions Act of 2023 (HB 99)
- State Agency Climate Officers requirements
 - Meet at least bi-annually
 - Assess progress on reducing Greenhouse emission goals, evaluate status of actions
 - Provide information needed for Climate Action Plan, help draft sections of Climate Action Plan, work with cabinet secretary to provide input from department, maintain/hold professional certifications (yet to be identified))
 - o Maintain an all of government approach
 - Opportunity to ensure Climate Action Plan represents the needs of agencies and works for the agencies
 - o Goal is for the Climate Officers group to be an opportunity, not a burden

Opportunities to engage in Climate Action Plan Development

- <u>Climate Action Plan</u> and Opportunities for Engagement
 - o The plan was released in November 2021.
 - o The 2023 Implementation Report is available
 - Work is underway on the 2025 Climate Action Plan, focusing on emissions modeling and strategy drafting. Public engagement and technical expert engagement occurred this fall.
 - Arrangements are being made for three more public workshops, with one planned for each county in Delaware. The tentative dates are May 14th to May 26th.
 - Climate Officers packages will be available soon.
 - Packages will include:
 - Contact information
 - Agency staff who have engaged thus far on 2025 climate action plan
 - Previous resiliency recommendations by agency
 - Trainings on climate change available on DE Learning Center
- RASCL Summit
 - March 5, opportunity to learn more about climate change projections

Discussion: Agency needs for training, guidance and tools

- A discussion was held regarding the most effective approach for Climate Officers to coordinate moving forward.
 - Attendees agreed to establish an online portal for document storage and collaboration through a Microsoft Office Teams Channel.
- Climate Officers were asked to identify any near- or long-term training needs within their respective agencies.
 - A member inquired whether workforce development and youth engagement would be incorporated into the training plan.
 - A comment was made highlighting Maryland as a strong example, noting that its climate change plan includes youth engagement.
- Attendees were asked whether they had any requests for additional presentations on specific topics.
 - No requests for additional presentations were made.

Public Comment

- During the public comment period, the following remarks were made:
 - o A commenter expressed appreciation for the agency's collaboration efforts.
 - o Another commenter raised interest in several key areas, including:
 - Statistics on Delaware's emissions and their global impact.
 - The challenge of balancing resiliency with competing goals across various sectors and supply chains.
 - The importance of adopting a broader perspective to ensure resiliency is not compromised in pursuit of greenhouse gas reductions.
