NOTICE TO APPLICANTS

- Pursuant to *7 DE Admin Code 3900 Wildlife, Subsection 20.0 Game Bird Releases*, anyone possessing and/or releasing upland gamebirds into the wild must receive a permit from the Delaware DNREC Division of Fish and Wildlife (FW).
- Upland gamebirds approved for possession and/or release include **quail, chukar partridge, Hungarian partridge, and pheasants**.
- Permits are valid from the date of issuance through June 30th.
- Anyone possessing and/or releasing 25 or fewer total upland gamebirds, in any combination of the four allowable species combined, will receive a Gamebird Release Permit. This permit is free.
- Anyone possessing and/or releasing 26 or more upland gamebirds, in any combination of the four allowable species combined, will receive a Gamebird Breeder’s Permit. This permit is \$17.50.
 - Cash and checks accepted. Checks should be made payable to the "Delaware Division of Fish and Wildlife. Credit cards accepted, except American Express, at the Richardson and Robbins Building, 89 Kings Hwy, Dover, DE 19901.
- Anyone releasing quail must provide the specific location(s) upon which the release(s) will take place. The proposed release location(s) will be considered by FW and must be approved before any quail are released.
- Before releasing upland gamebirds, permittees must tag each bird with an approved auxiliary marker.
 - All auxiliary markers must be **yellow** in color.
 - Approved auxiliary markers include **nasal discs and saddles, patagial markers, seamless leg bands, metal butt-end leg bands, plastic or metal leg bands that have a locking clasp, or plastic bandettes**.
