## Outdoor Recreation, Parks and Trails Program

### Trail Grant Guidance

#### Program Summary

The Outdoor Recreation, Parks and Trails (ORPT) Program, formerly known as the Delaware Land and Water Conservation Trust Fund (DTF) was established in 1986 as an investment of state monies to provide a stable source of funding for the acquisition of open space and the development of outdoor recreation projects. The ORPT Grant Program is administered by the Delaware Department of Natural Resources and Environmental Control, through its Division of Parks and Recreation, and Trust-earned income is used to fund the competitive Program. Annually, local governments and park districts are notified of available matching funds to assist with park planning, acquisition, and development.

#### Eligible Grant Applicants

County and municipal governments and park districts may request and receive ORPT grant assistance. Projects sponsored by municipalities and counties may receive up to fifty percent (50%) in DTF assistance of an approved project's total costs; park districts, municipalities that have not received ORPT funds in the past, and projects located in or serving Census Tracts identified as highest vulnerability by the CDC Social Vulnerability Index (SVI score range 0.75 – 1.00) are eligible to receive up to seventy-five percent (75%) in ORPT assistance of an approved project's total costs. The CDC Social Vulnerability Index can be found at <https://svi.cdc.gov/map.html>. The balance of funding of an approved project must be provided by the project Sponsor. The Sponsor may obtain its share through partnerships with other governmental agencies, non-profit organizations, and other non-traditional recreation providers. Partnerships with other agencies and organizations are encouraged however, only the municipalities and counties are eligible to apply for ORPT assistance.

#### Eligible Projects

ORPT Program assistance is available for trail projects within parks or public right of ways:

- Trail, pathway or riverwalk pre-construction (design and engineering)
- Trail, pathway or riverwalk construction (paved)
- Trail construction within a park
- Development of trailheads and associated facilities and infrastructure (parking, information boards and kiosks, restrooms, composting toilets, electricity, water)
- Pedestrian and bicycle bridges
- Trail improvements that facilitate access to and use of trails by persons with disabilities
- Development and installation of trail markers or directional signs
- Water trail planning and development
- Acquisition of conservation greenway corridor lands for wildlife habitat, stream corridor protection, buffer preservation, forest preservation, and historic or cultural sites
- Acquisition of fee simple title to property for trail development
- Educational or interpretive brochures and wayside exhibits for a specific trail or conservation greenway

- Trail or greenway corridor maps for information board or kiosks
- Municipal or County Comprehensive Greenway Corridor or Trail Plans

Costs associated with trail operations and maintenance are NOT eligible for ORPT Program assistance.

## Long Term Responsibilities

When an eligible grant application has received all approvals, the Division of Parks and Recreation will prepare a Grant Agreement outlining the project scope, funding, and responsibilities of both the State and the Sponsor. The Grant Agreement is a contract between the State and the Sponsor and is signed by each. When a Sponsor accepts ORPT Program assistance, the Sponsor agrees to dedicate the land acquired or improved with ORPT Program assistance to public outdoor recreation use in perpetuity and assume responsibility for continued operation, maintenance, and stewardship of the area.

## Grant Match Sources

The following funding sources may be used to match Delaware Land and Water Conservation Trust Fund:

- City/ County cash
- Transportation Enhancement (SAFETA, FHWA)
- Federal grant funds (NERR, NOAA, EPA)
- Community Transportation Funds (CTF)
- Corporate or private donations
- Foundation grants
- Donated materials or labor
- Volunteer or in-kind labor
- Value of land (only if pre- approved by the Division of Parks and Recreation)

A Sponsor's expenses associated with administering and managing an approved ORPT grant is NOT eligible for reimbursement or a source of match.
