



DSSP Bubble Diagram

- Improves vehicle circulation within the park boundaries
- Provides a larger, centrally located camp store
- Allows for larger pullthrough and back in RV spaces with 3-point hook ups
- Dedicated tent camping space
- Provides additional overflow parking








DSSP Schematic

- Provides 19 back-in spaces and 8 pull-thru spaces
- RV space size is standardized and can accommodate larger campers
- All RV spaces will have 3point hook ups (water, sewer, and electricity)
- Provides 39 overflow parking spaces
- Duplex cottage units to maximize space
- Enhanced platform and shaded tent camping
- Potential for diverse camping opportunities



















- Can be ADA accessible
- Provides view of surrounding wetland
- Expansive outdoor living area







- IRM Bubble Diagram
 - Additional cottages provided within existing cottage area
 - Maintains existing traffic circulation
 - Maintains secluded feel







- Two-story layout where units can be rented separately or together to host larger family groups
- Full-service cottages with outdoor living space
- Two-story layout provides views of surrounding nature and ADA compliant options
- Provides additional parking to accommodate new cottages
- Expanded and enhanced communal area
















- 3-bedroom layout. Units could be rented simultaneously for 6 bedrooms
- Large windows for natural light and views
- First floor is ADA accessible
